

FIELD CONDITIONS:

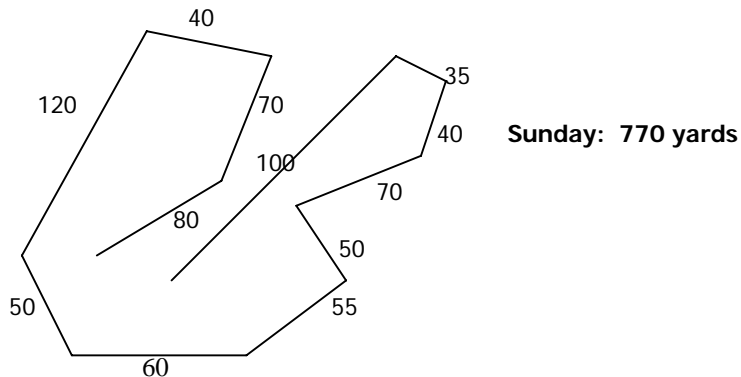
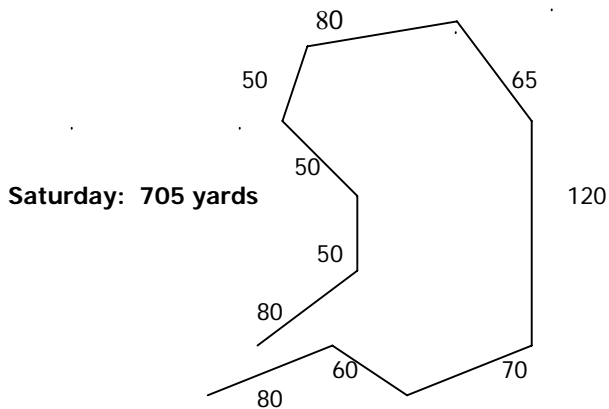
This is a very well maintained 30 acre hay field. Parking will be on the field – no on-street parking. By request of the field owner, **NO MOTORHOMES, CAMPERS, TRAILERS (heavy vehicles) WILL BE PERMITTED ON THE FIELD.**

DIRECTIONS TO FIELD:

From the west: take the 200th Street exit off Hwy. 1 – go north. Go 1.5 km and turn right onto 96th Avenue (light). Follow 96th for approx. 5 km – when the road curves to the right, the field will be on your right – enter the farm gate just **before** the bridge.

From the east: take the 232nd Street exit off Hwy. 1 – (follow signs to Ft. Langley) turn left (north) at the stop sign at the top of off-ramp, follow road to the stop sign at the T-intersection and turn right onto Glover Road. Go into Fort Langley village and turn left onto 96th Avenue (next left after cemetery). Go across the Railway tracks, past Bedford Landing sign (on your right), cross the bridge and the field entrance is **immediately** on your left, approximately 1.1 km from Glover Road.

COURSE PLANS: Not to scale. May be altered due to weather/field conditions.

ELIGIBLE ENTRY:

For any Afghan Hound, Basenji, Borzoi, Scottish Deerhound, Greyhound, Ibizan Hound, Pharaoh Hound, Saluki, Whippet, or Irish Wolfhound that is one year of age or older on the date of the trial. All entrants must be registered with, or eligible for registration with, the Canadian Kennel Club. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible.

STAKES OFFERED:

OPEN: for all hounds including Field Champions
MIXED: for multiple breeds with entries of three or less, upon owners' agreement
SINGLES: for any hound that is one year of age or older, not entered in the official trial. Will run individually, twice, on a full course. No Championship points awarded. LIMITED TO 10. Saturday Only.
PUPPIES: for any hound 8 months but less than 12 months of age on the day of the trial. Puppies will run once individually on a shorter course. LIMITED TO 10. Sunday Only.
BEST IN FIELD: Sunday only – for Sat/Sun Best of Breeds & 1st in Mixed Stake

EQUIPMENT:

Gas powered drag line lure machine with white plastic streamers.

PRIZES:

Prizes will be awarded to all Best of Breed winners, 1st in Mixed Stake, and Best in Field. Rosettes will be offered all placements 1st thru NBQ.

CHAMPIONSHIP POINTS:

Will be awarded as follows: 1st place - four times number competing to a maximum of 40 points; 2nd place - three times number competing to a maximum of 30 pts.; 3rd place - two times number competing to a maximum of 20 pts; 4th place - one times the number competing to a maximum of 10 points; NBQ - no points awarded.

CREDIT CARD ENTRIES:

Fax entries will be accepted when accompanied by an authorised number. - \$3.00 per entry will be added for credit card entries. Customers whose charges are declined by the bank will be assessed \$20 for each transaction declined. Fax number: 604-856-5706 Charges will show on your statement to Country Tire.

ADDITIONAL INFORMATION:

- Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.
- Bitches in season/lame hounds will have entry fee refunded provided notice is given at or before Roll Call.
- Only the 1st place winner of the Mixed Stake may compete for Best in Field.
- Dogs not present at Roll Call will be scratched and entry fee not refunded.
- Coursing entries received after the closing date will be charged the late/day of trial fee.
- \$5.00 will be levied against the owner/handler of any hound loose on the coursing field.
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the trial site.
- A valid rabies certificate is required to bring a dog into Canada.
- Overnight camping is **NOT** permitted at the site.
- Washroom and food concession will be available.

IMPORTANT NOTICE:

Effective July 1998, hounds entering their first trial in Canada must be tested with another dog, not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form (included with this premium list) must be completed and submitted with their entry at the hound's first trial. Hounds with the following are exempt: ASFA F.Ch. or LCM, AKC F.Ch., S.C. or D.C. , but are still required to submit the Hound Certification form with their name and exempt title(s) circled.

ATTENTION US EXHIBITORS:

US owned dogs may compete with an Event Registration Number. This number must be obtained within 30 days of obtaining points, awards, or scores to avoid cancellation. An ERN can be obtained by submitting a copy of your AKC registration with a letter of request to the CKC offices. Fee is \$58.85(request may be faxed using VISA). An \$8.40 listing fee per trial is payable for each dog not showing a CKC or ERN or PEN registration number.
